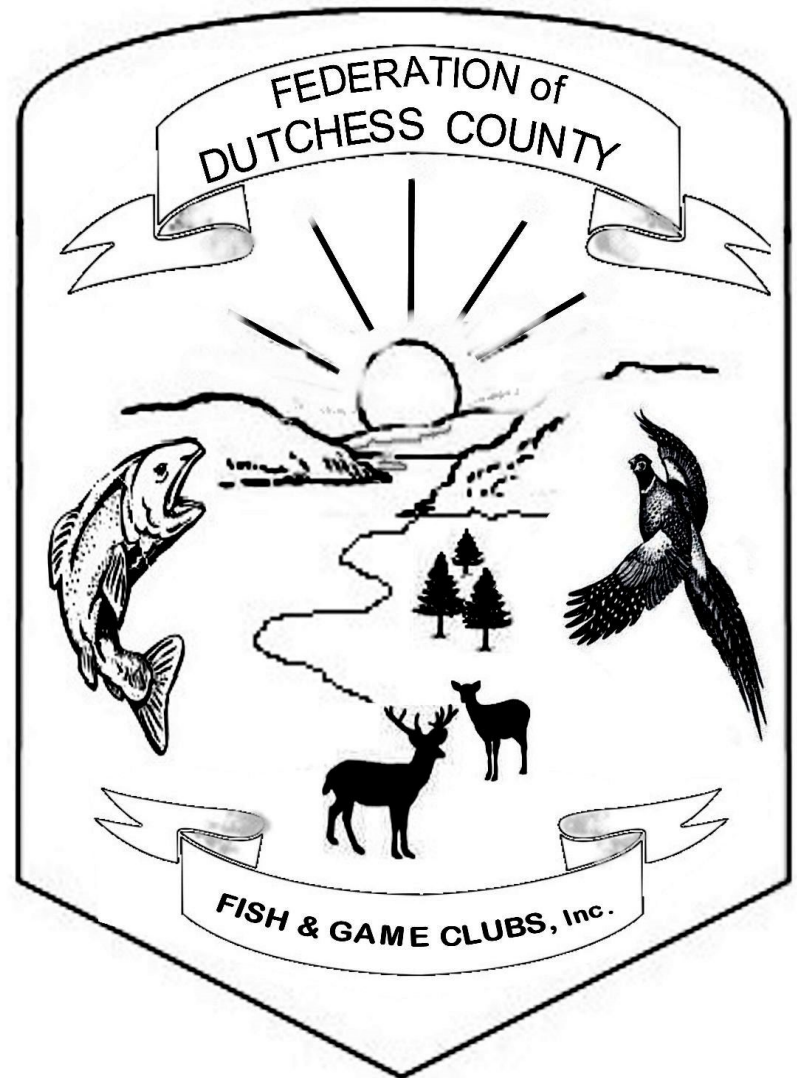

Every sportsman and sportswoman should be letting his or her elected representatives know how they feel about the legislation being promoted and debated, whether it be here in the Dutchess County Legislature, in the State Legislature in Albany, or in the House of Representatives and the Senate in Washington. If they don't hear from you, they are going to assume that you have no problem with how they are representing your interests in their respective legislative bodies.

We are constantly under fire in Albany and Washington, in part, because our elected representatives are not hearing from us. You cannot assume that someone else is making that call, writing that letter, or sending that email. We all have to be active participants in the legislative process. We have been losing ground for years, and things are not getting any better. Our gun rights have taken a beating, we are being deprived of access to public lands, and funding for fish and wildlife management programs continues to lag in spite of the taxes and fees we pay for our sporting goods and licenses.
